Treasurer Dave A.: Jan 3rd, 2021 Treasurer report to OTW ASC

Ending balance at last ASC was \$1394.43. After deposits of \$342.38 with debits of \$682.37 we had a yearend bank balance of \$1450.71. (Less an outstanding check of \$15.00) I deposited \$160.23 on the 2nd of January - \$50.00 from Fun Addicts and \$110.23 from Hope Shot.

However, I mailed check #1012 to the P.O. for 2021 rent. I picked up that bill in early December and had Sarah co-sign it on the 8th and mailed it on the 11th. When I went to the PO box to check it on the 18th it failed to open. So, after bouncing around from a window to the kiosk and back they had already closed the box. So, I went through the line and paid the bill with my credit card and got it reopened retaining our box number of 270075. To that end I would ask for reimbursement of \$118. Check #1012 was returned. I made a note in Novembers sheet to be aware that the PO box bill would be due soon for future reference.

Along with 4 other members I attended the inventory ad hoc. See results below. For next steps I would suggest one last meeting to further discuss solutions.
