The Solutions Group has closed the noon meeting at Glenmere Park in Greeley. The zoom meeting on Monday a 7pm is also getting shut down. We have a \$40.00 Area donation. In concern to the discussion of asking one of our trusted servants to step down. I would like to read a paragraph out of our Third Concept page 7.

Delegating authority can be a risky business unless we do so responsibly. To make Concept three work other concepts must also be applied consistently. Most importantly, we must give careful attention to the selection of trustworthy trusted servants. We cannot responsibly delegate authority either to those who are fundamentally incapable of administering that authority or to those who are not willing to account fully for their action. However, if we select our leaders carefully, choosing those who can be trusted to responsibly exercise delegated authority in fulfilling the tasks we've given them. We can feel much more comfortable with the Concept of delegation.

Fourth Concept page 9 any member can be a leader, and every NA member has the right to serve the fellowship. Effective NA leadership knows not only how to serve, but when it will serve best to step aside and allow others to take over. An entrenched bureaucracy inhibits our fellowships growth, while a regular influx of new leadership, balance by continuity, inspires NA growth. The effective leader also knows that in order to maintain the distinction in service between principles and personalities, it is important to observe the practice of rotation.

We would like to ask this person to step down, so that they can concentrate on their personal recovery. We are more interested in their wellbeing than their service.
